



#### LICENSES AND REGISTRATIONS

Swissfortcapitalfinance is committed to working closely and collaboratively with regulators from around the world. Swissfortcapitalfinance currently holds the following regulatory licenses, registrations, authorizations and approvals:

#### Europe

#### France (HEADQUARTERS)

Our France SAS has been granted registration as a Digital Asset Service Provider (DASP) by the Autorité des Marchés Financiers (AMF) (registration number E2022-037). Swissfortcapitalfinance France SAS can provide the following regulated services in France: digital assets custody; purchase/sale of digital assets for legal tender; exchange of digital assets for other digital assets; and operation of a trading platform for digital assets.

#### Italy

Swissfortcapitalfinance Italy S.R.L. has been granted a Digital Asset Service Provider (DASP) registration by the Organismo Agenti e Mediatori (OAM) (registration number PSV5). The registration enables Crypto-profits Italy S.R.L. to provide crypto asset exchange and custody services

#### Lithuania

Swissfortcapitalfinance has been granted a Virtual Asset Service Provider (VASP) registration by the Registry of Legal Entities of the Republic of Lithuania and local Financial Intelligence Unit (FIU) (registration number 305595206). The registration enables Swissfortcapital finance to provide crypto asset exchange and custody services.

#### Kazakhstan - Astana International Financial Centre (AIFC

Swissfortcapitalfinance KZ Technologies Limited has been granted a license by the Astana Financial Services Authority (AFSA) to operate a digital asset platform and provide custody services in the Astana International Financial Centre (AIFC).

#### United States (USA)

Swissfortcapitalfinance USA affiliate and Capital Market LLC has been granted a Financial Services Permission(FSP) by the Financial Services Regulatory Authority to carry out the Regulated Activity of Providing Custody, in relation to Virtual Assets. Once Swissfortcapitalfinance (ATL) Limited has met the conditions set out in its FSP, it can commence providing custody services to Professional Clients. Swissfortcapitalfinance Investment Management Limited has been granted a Financial Services Permission (FSP) by the Financial Services Regulatory Authority to carry out the Regulated Activity of Managing a Collective Investment Fund. Once BV Investment Management Limited has met the conditions set out in its FSP, it can commence providing fund management services to Professional Clients.

#### Bahrain

Swissfortcapitalfinance Bahrain ATL(c) has been granted a Category 4 licence as a Crypto-Asset Service Provider(CASP) by the Central Bank of Bahrain. The licence enables Swissfortcapitalfinance Bahrain ATL © to operate as a crypto asset exchange services provider and a crypto-asset custody service.

#### Dubai World Trade Center (DWTC)

Swissfortcapitalfinance has been granted a Virtual Asset Service Provider (VASP) MVP licence by the Virtual Asset Regulatory Authority (VARA). The MVP licence enables Swissfortcapitalfinance to offer products or services approved by VARA including but not limited to Exchange Services, Custodial Services, Broker-Dealer Services and Payments and Remittance Services to qualified investors initially
